**Because of COVID-19 and the JBER guidance regarding golf tournaments at Moose Run, we will be conducting the tournament in one of two ways, depending on the Base OPCON health status.**

**Option A. We will conduct a shotgun scramble tournament where all teams will start from assigned holes at the same time (0700 hours). Check in time will begin at 0545 hours and may or may not be located in four different pod areas. Information will be provided to team Captains prior to the tournament date. There will be lunch and awards provided following the tournament.**

**Option B. Instead of a shotgun start we must stagger start times ten (10) minutes apart. Depending on the number of teams we will start teams on hole 1 and hole 10. (maximum of 30 teams). Teams will be assigned starting holes (hole 1 or hole 10) and team Captains will be advised of their team starting time and hole prior to the date of the tournament. Teams will check in at their starting hole 15 minutes prior to their starting tee time. This will allow time for the team to check in, get their swag bag, purchase mulligan bags if they wish, and get to their starting tee (either hole 1 or hole 10), Tee times will be assigned and team captains will be notified of their teams starting tee time and hole prior to the date of the tournament. It is important that team captains provide a good phone number and legible email address for this purpose.**

**Under this option there can be no group picnic at the end of the tournament as in the past. Instead we will provide box lunches at the picnic pavilion and will be available as the teams finish. Tables will be arranged to insure 6 foot spacing. Teams can stay, eat lunch and then leave or take the box lunches with them. We will still have prizes for some, or all, of the E-6 and below Soldiers who participate, and the names will be drawn while the players are on the course. When a team finishes and comes to the pavilion, the qualified Enlisted Soldiers can look at the prize table to determine if they were drawn for a prize. Other awards such as longest drives, closest to the pin, and first, second, and third place teams will be determined after all players have finished and winners will be contacted by phone and arrangements will be made to get their awards to them.**
